The Business Manager explained that the presentation of the 2017 Proposed Budget is the same as it was at the Budget Workshop with the exception of the correction to fund balance title on the presentation from PACS Mobile to Financial Software. Advised the Board that PTC requires them to set the date, time and place of the Budget Public Hearing.

Mrs. Gerthe made a motion to set the date, time & place of the Public Hearing for June 16, 2016 at 8:30 a.m. at 120 N. Houston, Cameron, Texas, Mr. Patterson seconded the motion, vote was unanimous.

- b. Receive 2016 reappraisal plan report The Business Manager stated that the Notices of Appraised Value went out on April 29th. All staff is currently involved in assisting property owners with informal reviews of their property. As of Wednesday, May 11th, we have conducted 664 informals. We have just over 300 formal protests filed. Our hearings will begin May 26th. The Chief Appraiser estimates we will have 700 -1000 protests.
